1. Call to order

The meeting was called to order by Mayor Brown at 7:05 pm.

2. **Agenda**

Motion 2020:38 It was moved by Councillor Andrews and seconded by Councillor Duplain that a revision to the Agenda include the letter received today from the Town of Kensington regarding Fire Dues. With this revision the Agenda is approved. **MOTION CARRIED**

3. **Disclosure of Conflict of Interest** There were no conflict of Interest items on the Agenda

4. Introduction of Jamie MacKay representing Canadian Red Cross

Mayor Brown introduced Mr. MacKay.

Mr. MacKay began his presentation noting that he is a volunteer with the Canadian Red Cross. He is one of 66 Province wide. He shared some of his 'most rewarding' experiences as a volunteer with the Red Cross. Some areas that the Red Cross work in the community is through programs such as Swimming and Water and Safety programs, First Air Courses, as well as assisting families following home fires as well as disaster relief to communities at large. He noted that the Town of Kensington provided him with an office where he is able to store a quantity of emergency provisions that may be used in the area such as cots, blankets, personal items, as well as kits designed for clean up following some disasters.

He identified that the Red Cross may provide emergency food, emergency clothing, personal services and family reunification services. Mr. MacKay identified the Health Equipment Loan Program offered to people free of charge for people recovering from illness or surgery allowing people to remain in the homes.

Often chaos and confusion accompany disasters and can separate families. The Red Cross offers help to re-establish contact with immediate family members through a registration process.

Mr. MacKay indicated his willingness to help the Municipality in establishing an EMO Plan. It was noted that the Municipality hopes to share services with the Town of Kensington and that an Agreement to share services in a crisis hopefully will be formulated together in the months ahead.

The Mayor, on behalf of Council sincerely thanked Mr. MacKay for his continued service to the Red Cross and to our communities.

5. Approval of Minutes

6. Business arising from minutes

It was noted that we had not received any response from our ad asking the public for input into community signage. A call from a graphic designer interested in creating a sign for a fee had been received. This person lives outside the municipality. A discussion followed and Council members were encouraged to come up with a sign for consideration at the May Council meeting.

7. Budget 2020-2021

It was noted that a letter had been received from the Town of Kensington on March 10, 2020 identifying an increase in the fire dues from \$79,295.04 to \$87,360.00. Discussion followed.

The Budget was reviewed and discussed. Because of the 10% increase in fire dues mandated by the Town of Kensington, it was moved by Councillor Andrews and seconded by Deputy Mayor Clark to set the tax rate at 0.075 cents to allow the municipality to break even in the upcoming fiscal year and to accept this revision to the Budget. The Nil Capital Budget was approved as presented. **MOTION CARRIED**
